There will be one (1) grand prize winner selected at random from the eligible form entries. The winner will win a Mother's Day bouquet from Welke's Milwaukee Florist, a (1) night at Saint Kate The Arts Hotel and a \$100 gift card for a restaurant of your choice in the hotel (Aria, Giggly, Proof Pizza, the Bar).  - i. To participate in the Promotion, you may log onto www.WelkesMothersDay.com and follow the links and instructions to enter the Promotion and submit your first and last name, complete address, city, state, zip code, telephone number, date

of birth, and a valid email address in the online entry form. Only one internet entry per person and one internet entry per email address is permitted. There will be a total of one (1) winner randomly selected online for this Promotion to win the grand prize upon confirmation of eligibility. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry.
