

Welke's Sweetest Day Giveaway

CONTEST OVERVIEW

ESPN Milwaukee fans will have the chance to win a Sweetest Day prize courtesy of Welke's Milwaukee Florist. Fans must register to win by filling out the online form via the contests page at www.WelkesSweetestDay.com beginning on Wednesday, October 7, 2021 at 7AM CST and ending on Wednesday, October 13, 2021 at 12PM CST. There will be one (1) grand prize winner selected at random from the eligible form entries. The winner will win a Sweetest Day bouquet and package from Welke's Milwaukee Florist, a \$100 gift card to Lou Malnati's Pizzeria, and (2) 3L boxes of Bota Box wine. The total ARV of the prize is \$275.00.

1. HOW TO ENTER

- a. These rules govern Welke's Sweetest Day Giveaway (the "Promotion") being conducted by 94.5 ESPN, WKTU, 720 E Capitol Dr, Milwaukee, WI 53212 ("GKB") beginning on Wednesday, October 7, 2021 at 7AM CST and ending on Wednesday, October 13, 2021 at 12PM CST.
- b. To participate in the Promotion, you may enter via the following method(s):
 - Submit your online entry form at www.WelkesSweetestDay.com
 - i. To participate in the Promotion, you may log onto www.WelkesSweetestDay.com and follow the links and instructions to enter the Promotion and submit your first and last name, complete address, city, state, zip code, telephone number, date of birth, and a valid email address in the online entry form. Only one internet entry per person and one internet entry per email address is permitted. There will be a total of one (1) winner randomly selected online for this Promotion to win the grand prize upon confirmation of eligibility. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning an email address or the domain associated with the submitted email address. Multiple participants are not permitted to share the same email address. Entries submitted may not be acknowledged or returned. Use of any device to automate entry is prohibited.

2. ELIGIBILITY RESTRICTIONS

Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, [other radio stations in Milwaukee and the surrounding area and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.
- b. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every seven (7) days and only once every thirty (30) days if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.

The total ARV of the prize is \$275.00. The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Prize. GKB accepts no responsibility for repairing any real or supposed damage to any prize. - b. The grand prize winner must complete any required prize forms to accept the prize by 5pm CST on Thursday, October 14, 2021. If the selected winner does not accept by 5pm CST on Thursday, October 14, 2021, a new winner may be selected in their place.

GKB will coordinate a safe delivery of the prize on Friday, October 15, 2021. The selected winner must be able to receive the delivery on Friday, October 15, 2021 between the hours of 9am and 5pm in order to be eligible to win. Winner must be present and able to show a valid ID to accept the prize.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. There will be one (1) winner selected at random from the online form at www.WelkesSweetestDay.com to win the prize. GKB's promotions team will contact the winner via their provided phone number or email address by 5PM CST on Wednesday, October 13, 2021 to share the necessary prize forms and coordinate the delivery of the prize.
- c. Odds of winning the Grand Prize depends upon the number of online entries received, the ability to meet the eligibility requirements, and random selection.
- d. Fans must complete the online entry form and be randomly selected in order to win.
- e. The one (1) winner will be contacted by the phone number or email provided in their submission after they are randomly selected.
