

Green Bay Schedule Predictions

OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.

1. HOW TO ENTER

- a. These rules govern the “Green Bay Schedule Predictions” promotion (the “Promotion”) being conducted by ESPN Madison, 15 N. Pinckney St, Suite 100, Madison, WI 53703 (“GKB”) beginning on Thursday, April 19, 2018 at 9:00 AM CST and ending on Thursday, April 19, 2018 at 3 PM CST.
- b. To participate in the Promotion, you may enter via the following method(s):
 - i. To participate in the Promotion, you may log onto www.Twitter.com (“Page”) and if you do not already “Follow” the account, then you must “Follow” @WildeAndTausch on Twitter (www.Twitter.com/WildeAndTausch) in order to access the Promotion and then post a tweet tagging @WildeAndTausch including the following items: the first four (4) games you predict Green Bay will play in order in the 2018 regular season, including the opponent and if each game will be played in Green Bay or at the opponent’s stadium. You must have a valid Twitter account in order to enter and your Tweet Privacy must be set to un-protected. If you do not already have one, you can create a Twitter account at no cost by visiting <http://www.twitter.com>. Limit (1) entry per eligible person during the Entry Period regardless if entrant has more than one email address or Twitter account. Multiple participants are not permitted to share the same email address or Twitter account. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by GKB. Internet entrants are subject to all notices posted online including but not limited to GKB’s Privacy Policy. Use of Twitter as a means of entry will be subject to Twitter’s privacy policy and terms of service. By participating in the Promotion, entrant understands that he or she is providing his or her information to GKB and not Twitter. Further, entrant specifically agrees to release Twitter from any and all liability associated with this Promotion. The Promotion is in no way sponsored, endorsed or administered by, or associated with, Twitter. GKB is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties or other technological problems.

c. Limit one entry per person. Entries are only accepted via Twitter submissions. All entries must be submitted by 3 PM CST on Thursday, April 19, 2018 to be considered for the promotion.

2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 18 years of age and older and who reside in the Greater Madison Metropolitan Area or the Greater Milwaukee Metropolitan Area. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.

General admission tickets are valid for any single day of the tournament from June 22-24, 2018. The Approximate Retail Value ("ARV") of each general admission ticket is \$20.00 USD. The Approximate Retail Value ("ARV") of the prize (4 general admission tickets) is \$80.00 USD. The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Prize. - b. All prizes or prize certificates may be picked up at the office of GKB at the address below. The winner will forfeit any prize or prize certificate not claimed within ten (10) days of winning. GKB is not responsible for the safe arrival of a prize or prize certificate.
- c. All prizes or prize certificates may be picked up at the office of ESPN Madison at 15 N Pinckney St, Suite 100, Madison, WI 53703 between the hours of 8 AM CST and 5 PM CST. If winner resides in the Milwaukee DMA they can choose to pick up the prize at the office of ESPN Milwaukee at 310 West Wisconsin Avenue, Suite 100, Milwaukee, WI 53203 between the hours of 8 AM CST and 5 PM CST. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. 4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. One (1) winner will be determined by Thursday, April 26, 2018 at 9:00 AM CST based on who had the most correct game and location predictions once the official schedule is released. If there is a tie between entries for number of correct predictions, the winner will be randomly selected from the tied entries.
- c. The final winner will be determined by Thursday, April 26, 2018.
- d. Odds of winning the Prize depends upon the number of entries received and how many correct game and location predictions the winning entry had compared to other eligible entries.
- e. Winner does not need to be present to win or listen to 100.5 ESPN. Winner must follow @WildeAndTausch on Twitter.
- f. Winner will be announced during 'Wilde & Tausch' on 100.5 ESPN Madison and 540 ESPN Milwaukee between 9 AM-11 AM CST by Thursday, April 26, 2018. The winner will be contacted via direct message or a reply from the Wilde & Tausch account on Twitter. The winner must

execute and return any required affidavit of eligibility and/or liability/publicity release within ten (10) days of winning or prize will be forfeited and the runner-up winner will be selected based on number of correct game and location predictions. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.
