

## Wilde & Tausch Photo Contest

### OFFICIAL RULES

***NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.***

**DESCRIPTION:** ESPN Madison is conducting a contest on Wilde and Tausch for one winner to win a Wilde and Tausch mug. In order to enter, you must tweet @WildeandTausch the best photo that you have ever taken. Whichever contestant Jason Wilde, Mark Tauscher, and Jesse Nelson feel has tweeted the “best” photo, will win the mug. Photos will be taken into consideration starting Thursday, February 13, 2020 at 12 PM CST through Thursday, February 13, 2020 by 11:59:59 PM CST.

#### 1. HOW TO ENTER

- a. These rules govern the “Wilde and Tausch Photo Contest” promotion (the “Promotion”) being conducted by ESPN Madison, 15 N. Pinckney St, Suite 100, Madison, WI 53703 (“GKB”) beginning on Thursday, February 13<sup>th</sup>, 2020 at 12 PM CST and ending on Thursday, February 13<sup>th</sup>, 2020 at 11:59:59 PM CST.
- b. To participate in the Promotion, you may enter via the following method(s):
  - i. To participate in the Promotion, you may log onto [www.Twitter.com](http://www.Twitter.com) (“Page”) and if you do not already “Follow” the account, then you must “Follow” @WildeAndTausch on Twitter ([www.Twitter.com/WildeAndTausch](http://www.Twitter.com/WildeAndTausch)) in order to access the Promotion and tweet a picture of the best photo that you have taken to @WildeandTausch. You must have a valid Twitter account in order to enter and your Tweet Privacy must be set to un-protected. If you do not already have one, you can create a Twitter account at no cost by visiting <http://www.twitter.com>. Proof of submission of an entry shall not be deemed proof of receipt by GKB. Internet entrants are subject to all notices posted online including but not limited to GKB’s Privacy Policy. Use of Twitter as a means of entry will be subject to Twitter’s privacy policy and terms of service. By participating in the Promotion, entrant understands that he or she is providing his or her information to GKB and not Twitter. Further, entrant specifically agrees to release Twitter from any and all liability associated with this Promotion. The Promotion is in no way sponsored, endorsed or administered by, or associated with, Twitter. GKB is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties or other technological problems.

c. Entries are only accepted via Twitter follows. All entries must be submitted by 11:59:59 CST on Thursday, February 13<sup>th</sup>, 2020 to be considered for the promotion.

## 2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 18 years of age and older and who reside in the Greater Madison and Milwaukee Metropolitan Areas. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.
- b. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every seven (7) days and only once every thirty (30) days if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.
- c. The winner must provide valid government-issued photo identification and provide his or her complete address, date of birth and phone number to claim a prize.
- d. Entrants are required to provide truthful information and GKB will reject and delete any entry that it discovers to be false or fraudulent. GKB will disqualify any entry from individuals who do not meet the eligibility requirements.

## 3. PRIZES

- a. One (1) prize will be awarded in this Promotion. The prize consists of the following:
  - One (1) Wilde and Tausch mug
- b. All prizes or prize certificates may be picked up at the office of GKB at the address below. The winner will forfeit any prize or prize certificate not claimed within ten (10) days of winning. GKB is not responsible for the safe arrival of a prize or prize certificate.
- b. There is no substitution, transfer or cash equivalent for prizes, except that GKB may, at its sole discretion, substitute prizes or cash of comparable value. The prizes are expressly limited to the item(s) listed above and

unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Other restrictions may apply.

#### 4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. One (1) winner will be selected on Friday, February 14th, 2020 by 12 PM CST based on which photo was deemed the "best" from the opinions of Jason Wilde, Mark Tauscher, and Jesse Nelson.
- c. The final winner will be determined by Friday, February 14th, 2020 by 12 PM CST.
- d. Odds of winning the Prize depends upon the number of entries received and the decision of the best photo by Jason Wilde, Mark Tauscher, and Jesse Nelson.
- e. Winner does not need to be present to win.
- f. Winners will be announced on Friday, February 14th, 2020 via Twitter and on-air. The winners will be contacted via direct message or a reply from the Wilde and Tausch account on Twitter or via email. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within ten (10) days of winning or prize will be forfeited and the runner-up winner will be selected based on number of correct team predictions. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.

#### 5. CONDITIONS

- a. Payments of all federal, state and local taxes are solely the responsibility of the winner. The winner will be required to complete and submit an IRS Form W-9 with the winner's full Social Security Number or the equivalent for receipt of any prize valued at \$600 or more or for any prizes awarded by GKB in a calendar year with an aggregate value of \$600 or more. - e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website.
