

## WITH OR WITHOUT CRAIG CONTEST RULES

### OFFICIAL RULES

***NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.***

#### CONTEST OVERVIEW

ESPN Wisconsin will execute a contest to giveaway the opportunity to attend a Milwaukee Bucks basketball game with or without Craig Karmazin. Fans can enter via an online form on [ESPNWisconsinContests.com](http://ESPNWisconsinContests.com). The contest runs from 7:00 AM CST on Monday, January 13, 2020 through 11:59:59 AM CST on Friday, January 24, 2020. There will be one grand prize winner selected on Friday, January 24, 2020 promptly at 12:00 PM CST.

#### 1. HOW TO ENTER

- a. These rules govern the With or Without Craig promotion (the "Promotion") being conducted by ESPN Milwaukee, 720 E Capitol Drive, Milwaukee, WI 53212 ("GKB") beginning on Monday, January 13, 2020 at 7:00 AM CST and ending on Friday, January 24, 2020 at 11:59:59 AM CST.
- b. To participate in the Promotion, you may enter via the following method(s):
  - i. To participate in the Promotion, you may log onto [ESPNWisconsinContests.com](http://ESPNWisconsinContests.com) and follow the links and instructions to enter the Promotion and submit your first and last name, complete address, city, state, zip code, telephone number, date of birth and a valid email address in the online entry form. Only one internet entry per person and one internet entry per email address is permitted. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning an email address or the domain associated with the submitted email address. Multiple participants are not permitted to share the same email address. Entries submitted will not be acknowledged or returned. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by GKB. GKB's computer is the official time keeping device for the Promotion. GKB is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties or other technological problems. Each entrant must agree to GKB's online submission release in order to submit his or her entry.
- c. Only one online entry will be accepted per person.

#### 2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 21 or older and who reside in the Greater Milwaukee and Madison Metropolitan Area. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, other radio stations in the Milwaukee and Madison metropolitan area and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.
- b. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every seven (7) days and only once every thirty (30) days if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.
- c. The winner must provide valid government-issued photo identification and provide his or her complete address, date of birth and phone number to claim a prize.
- d. Entrants are required to provide truthful information and GKB will reject and delete any entry that it discovers to be false or fraudulent. GKB will disqualify any entry from individuals who do not meet the eligibility requirements.

### 3. PRIZES

  - (2) courtside tickets to the Friday, January 31, 2020 Milwaukee Bucks game vs the Denver Nuggets. The grand prize winner can bring a guest to the game with them. The grand prize winner will also receive an additional prize from Door County Distillery and Door Peninsula Winery consisting of either a gift basket or gift card. The Approximate Retail Value of the prize is \$3,050.

OR

- (1) courtside ticket to the Wednesday, March 4, 2020 Milwaukee Bucks game vs the Indiana Pacers. Sit with GKB Founder/CEO and Milwaukee Bucks owner Craig Karmazin. The grand prize winner will also receive an additional prize from Door County Distillery and Door Peninsula Winery consisting of either a gift basket or gift card. The Approximate Retail Value of the prize is \$1,550.

The grand prize winner will join Craig Karmazin on Sunday Karma for a segment on Sunday, January 26, 2019 to announce which game they will choose to attend.

If a selected event is unable to take place as scheduled, for reasons such as cancellation, preemption, postponement or unavailability, or for any reason

beyond the control of the Station, no substitution or compensation will be provided for the unawarded portion of the prize. GKB reserves the right to remove or to deny entry to the winner and/or travel companion(s) if either engages in a disruptive manner or with intent to annoy, abuse, threaten or harass any other person at the Milwaukee Bucks game.

- b. All prizes or prize certificates may be picked up at the office of GKB at the address below. The winner will forfeit any prize or prize certificate not claimed within one (1) week of winning.
- c. There is no substitution, transfer or cash equivalent for prizes, except that GKB may, at its sole discretion, substitute prizes or cash of comparable value. The prizes are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Other restrictions may apply.

#### 4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. Winner will be selected on Friday, January 24, 2020 at 12:00 PM CST.
- c. Winner must be available to join Sunday Karma on Sunday, January 26, 2020 between 10:00 AM – 12:00 PM CST. If the winner is not available at this time they will forfeit the grand prize and another contestant will be selected.
- d. Odds of a Qualifier winning the Grand Prize are dependent on the number of total entries that are received.
- e. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within one (1) week of winning or prize will be forfeited. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.

If the Promotion is terminated before the original end date, GKB reserves the right to select the winner(s) by random drawing from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winner(s).
- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, GKB reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.
- f. GKB reserves the right to make changes in the rules of the Promotion, including, without limitation, the substitution of a prize of equivalent value, which will become effective upon announcement.
