CONTEST OVERVIEW

94.5 ESPN, 301 W Wisconsin Ave, Suite 200, Milwaukee, WI 53203 will execute a contest to giveaway the opportunity to attend a Milwaukee Bucks basketball game with or without Craig Karmazin. Fans can enter via an online form on ESPNWisconsinContests.com. The contest runs from 7:00 AM CST on Monday, January 30, 2023, through 11:59:59 AM CST on Sunday, February 12, 2023. There will be one grand prize winner selected on Tuesday, February 14, 2023. The total ARV of the grand prize is \$1,500 if you go with Craig or \$3,000 if you go without Craig.

1. HOW TO ENTER

- a. These rules govern the With or Without Craig promotion (the "Promotion") being conducted by 94.5 ESPN, 301 W Wisconsin Ave, Suite 200, Milwaukee, WI 53203 ("GKB") beginning on Monday, January 30, 2023, at 7:00 AM CST and ending on Sunday, February 12, 2023, at 11:59:59 PM CST.
- b. To participate in the Promotion, you may enter via the following method(s):
 - Submit your online entry form at www.espnwisconsincontests.com.
 - i. To participate in the Promotion, you may log onto <https://goodkarmabrands.com/wisconsin-contest/with-or-without-craig-2/> and follow the links and instructions to enter the Promotion and submit your first and last name, complete address, city, state, zip code, telephone number, date of birth and a valid email address in the online entry form. Only one internet entry per person and one internet entry per email address is permitted. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning an email address or the domain associated with the submitted email address. Multiple participants are not permitted to share the same email address. Entries submitted will not be acknowledged or returned. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by GKB. GKB's computer is the official time keeping device for the Promotion. GKB is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties or other technological problems. Each entrant must agree to GKB's online submission release in order to submit his or her entry.

- c. Only one online entry will be accepted per person.

2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 21 or older and who reside in the Greater Milwaukee. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, other radio stations in the Milwaukee and Madison metropolitan area and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.
- b. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every seven (7) days and only once every thirty (30) days if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.
- c. The winner must provide valid government-issued photo identification and provide his or her complete address, date of birth and phone number to claim a prize.
- d. Entrants are required to provide truthful information and GKB will reject and delete any entry that it discovers to be false or fraudulent. GKB will disqualify any entry from individuals who do not meet the eligibility requirements.

3. PRIZES

- a. One grand prize will be awarded in this Promotion. The winner will have to choose between the following prize options:
 - (2) courtside tickets to the Friday, February 24, 2023, Milwaukee Bucks game vs the Miami Heat. The grand prize winner can bring a guest to the game with them. The ARV of this prize option is \$3,000.

- (1) courtside ticket to the Wednesday, March 1, 2023, Milwaukee Bucks game vs the Orlando Magic. Sit with GKB Founder/CEO and Milwaukee Bucks owner Craig Karmazin. The ARV of this prize option is \$1,500.

The grand prize winner will join Jen, Gabe and Chewy on Jen, Gabe and Chewy for a segment on Friday, February 17, 2023, to announce which game they will choose to attend.

If a selected event is unable to take place as scheduled, for reasons such as cancellation, preemption, postponement or unavailability, or for any reason beyond the control of the Station, no substitution or compensation will be provided for the unawarded portion of the prize. GKB reserves the right to

remove or to deny entry to the winner and/or travel companion(s) if either engages in a disruptive manner or with intent to annoy, abuse, threaten or harass any other person at the Milwaukee Bucks game.

- b. Upon confirmation of eligibility, GKB will share the grand prize winner's contact information with Ariens, who will coordinate the safe exchange of the prize. The winner will forfeit any prize or prize certificate not claimed within seven (7) days of winning. If the selected winner does not accept the prize by Monday, January 23, 2023, a new winner may be randomly selected in their place from the remaining eligible form entries. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. - a. Decisions of GKB management with respect to the Promotion are final.
- b. Winner will be selected on Tuesday, February 14, 2023.
- c. Winner must be available to join Jen, Gabe and Chewy on Friday, February 17, 2023, between 7 AM CST– 9 AM CST. If the winner is not available at this time, they will forfeit the grand prize and another contestant will be selected.
- d. Odds of a Qualifier winning the Grand Prize are dependent on the number of total entries that are received.
- e. Qualifiers must enter the contest on <https://goodkarmabrands.com/wisconsin-contest/with-or-without-craig-2/> to win.
- f. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within two (2) days of winning or prize will be forfeited. If the Promotion is terminated before the original end date, GKB reserves the right to select the winner(s) by random drawing from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winner(s).
- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, GKB reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.
